Tourettes Action is a charity that works to improve the lives of people with Tourette Syndrome and their families.

We provide information, support and advocacy for people with Tourette Syndrome (TS). Our work also includes educating people about the condition to help combat stigma.

Here are just some of the ways we support people with TS and their families:

- ★ A dedicated **Helpdesk** that offers advice and guidance about TS
- National Befriending Service which offers supportive relationships through volunteer befrienders
- * Regional **support groups** that meet regularly for people to share experiences and make new friends
- ★ An **online forum** where people can chat and share experiences of living with TS
- * TS identity cards to help people explain their condition.

How your donations help
